- Motion to approve the 2021-2022 SCD Budget of \$162,364.82 for submission to City Council. Charlie presented the detail on the changes, Denise motion, Kevin second approved.
- ➤ The second Digital Marketing Grant will go before city council 2021-002 Great Plains Taxidermy for \$1000.00

#### Housing Update - Brian

- Southeast NE Housing Summit, this was the first in person conference on housing. Brian Sloan state Chamber Director was a speaker. Was able to meet the new NIFA Director Shannon Hamer. In the panel discussion, identified two potential developers.
- ➤ Upcoming Housing Developer Community Tour will be hosting 2 developers from the Seward area to discuss lots, infranstructure and build options.
- > Available housing options, the choices are very limited.
- Rural Fellows Update Lydia thanked the group for her time in Schuyler. Excited to provide us with tutorials to carry forward on how to do web changes, podcasts, facebook information, etc.
- Directors Round Table Denise advised county had considered adding on, but the bid was double the estimate so project has been put on hold. Colfax, Saunders and Butler county are part of Rise which is for non violent felony offenders. The prosecutors picks who can go to the problem solving court process. The participants must pass a 9 month drug and alcohol free testing period.
- Lonnie asked about progress with JEO on Top Notch building. Also questioned if we ever received a price

from CHI Health. No updates on either projects.

- ❖ City of Schuyler Will not present
- ❖ Schuyler Department of Utilities Jim advised that crew is putting in 5 blocks of new cable. This will increase redundancy in the SW part of town. JEO is working with the Utility department for specifications on a sub T in the South East part of Schuyler. They are working in the Wagner Mills area to move the 3 way switches to a line of site. The sampling station will be back on line. They need to blend wells 22 and 23 (By solar field east 16th Street) with well 24. The nitrate level on well 24 is very low, Anything below 10 ppm is permittable. Most of our wells are in the 4-5 range. We are using 1.6 to 1.7 mllion gallons of water per day. A few days we used 2 million. We did not go to Stage 2.
